#### Sub-sea

Concordia's Marine Practice specialises in handling complex international subsea equipment claims.

Many claims in the subsea sector involve Remotely Operated Underwater Vehicles ("ROVs") and towed sonar arrays. Specialist subsea equipment includes Autonomous Underwater Vehicles ("AUVs"), Midget Submarines, Acoustic Positioning Systems and other Unmanned Underwater Vehicles ("UUVs").

Since their introduction in the 1970's ROVs have steadily replaced hazardous underwater diving operations, often in remote locations. In recent years the transition to fully diverless subsea operations in the offshore sector has seen deep water oil and gas reserves being primarily serviced by ROVs.

The subsea industry relies on a wide variety of ROVs, from smaller camera units through to large deep water fully garaged vehicles. Each ROV is tailored for the work required and could include cameras, lights, sonars, magnetometers, manipulators, tool skids, cutting equipment, scientific instrumentation and acoustic beacons.

During the last five to ten years we have also seen small and medium sized ROVs being incorporated into the vast array of 'toys' onboard large superyachts, often painted white!

Over the years we have been involved with claims including:

- 1. Lost equipment;
- 2. Severed umbilicals;
- 3. Contact damages (surface and subsea);
- 4. Electrical system and wiring failures;
- 5. Control system failures;
- 6. Topside operator error;
- 7. Vessel operations;
- 8. Mechanical system damages;
- 9. Manufacturing problems;
- 10. Theft of equipment.

Our marine team includes Marine Practice Leader James Gee, former Royal Navy Commander Ben Carroll, Spencer Clark, Marine Architect and Chartered Marine Engineer, and Paul May, Commercial Offshore Yachtmaster. All 4 are qualified scuba divers which assists with their appreciation of the underwater environment and challenges faced by the industry. James has many years experience in the London Market with specialist subsea equipment and has been involved with all types of ROV and underwater equipment claims.

Spencer has researched the effects of very deep water tether drag for ROV projects, and has spent time 'flying' and testing ROVs. During his marine surveying and insurance claims investigations Spencer has on many occasions had to supervise the use of ROVs.
