

Types of Data Breach

There is a misconception that most breaches are caused by malicious attacks. However it is actually human and system error that represents the majority of breaches.

Examples of common data breaches include:

- Loss of unencrypted portable devices
- Stray emails, letters, faxes, documents
- Inadequate destruction of data
- Technical security failures
- Malware / virus attacks (unsecured networks)
- Denial of service attacks
- Property crimes (stolen computers, mobile phones, USB drives)
- Inside job (employee steals information)
- Phishing scams
- Spear-phishing (social engineering)
- Advanced persistent threats


